CITIZENS FORUM

Mark Florence invited everyone to an annual meeting with the County Commission and the School Board for fellowship and discussions on December 10th, 2019 at 6pm.

Road Superintendent Buck Carter invited everyone to Lower Big Sandy Road. The new bridge is complete and will be dedicated in memory of Sonny Melton. Ceremony will start at 2pm on Tuesday, November 19.

Election Commissioner Mark Ward spoke about a petition against the 6M Bond Issue. He handed out a Debt Management Policy to the commissioners that was passed by the Commissioner in November 2011. Mr. Ward stated he was not against all the bond projects; he was against the way they were proposed. He also stated that the Bond Issue should go on the ballet for the County Citizens to vote on and more discussion and research should be done.

Mr. R.C.Mcgrady stated that he thought Mark Ward was saying to follow the law.

Mr. Dwayne Fowler says he supports the petition against the bond issue. He has gathered signatures from around the county for the petition.

COMMISSIONERS FORUM

Commissioner Ferguson invited everyone to a meeting on December 6th and 8:00 am at the First Methodist Church for an Economic Community Development Meeting. Guest speaker will be William Fruth (President of Policom).

Commissioner Ward said that no business that happens in the meetings is being posted on the front page of the Camden Chronicle for the people to see and read about. She stated that maybe Mr. Richardson should be contacted about this issue.

COUNTY MAYOR, ATTORNEY, FINANCE ADVISOR, INVITED GUEST SPEAKER FORUM, OR PROCLAMATIONS

Sheriff Christopher said he was having water heater issues at the jail and that some need replacing. The cost is upward of \$7,000 for 2 new heaters. He also voiced concerns about the bullet proof safety vests the officers wear and upgrades could be necessary.

Mayor Lashlee addressed concerns about the bond issue. Mayor Lashlee suggests that the Commission rescind last month's resolutions 16 & 17. He also says that he feels we have informed the public and prepped the Commissioners for this Bond. He stated that the Commissioners have been well informed. He also stated that the Bond issue WAS in the newspaper several times. Mayor Lashlee says he is committed to seeing that we follow thru with this financial plan. Furthermore, he stated that he thought the City of Camden would benefit from the Bond and was asking for a 50% commitment from them.
