WHEREAS, it is the recommendation of commissioners Presson, Plant, Powers, Vickers, Frazier, Dye, Hall and Hopper from the legislative body to amend the previous resolution dated June 17, 1985, and change the beer ordinance from within 300 feet to 300 feet (no change) of a residential dwelling pursuant to Tennessee Code Annotated, Section 57-5-105(i).

WHEREAS, the Benton County Commission passed a resolution on September 16, 1991 regarding the issuance of beer permits for the sale of beer in Benton County, Tennessee; and

WHEREAS, the resolution passed on September 16, 1991 forbid the sale of beer within 2,000 feet of a school, church, or other place of public gathering pursuant to Tennessee Code Annotated, Section 57-5-105(3); and

WHEREAS, it is the recommendation of the Benton County Mayor, Brett Lashlee, to amend the previous resolution dated September 16, 1991, and change the beer ordinance from within 2,000 feet to 500 feet of a school, church, or other place of public gathering pursuant to Tennessee Code Annotated, Section 57-5-105(b)(1) and for this resolution to take effect January 1, 2020.

budgeting of the county funds under his jurisdiction; and

WHEREAS, these tasks traditionally have been those of the executive assistant at a level of pay

well below that of the responsibilities; and

WHEREAS, the mayor's current executive assistant goes above and beyond in her fiscal responsibilities and continuous education for the betterment of Benton County; and

WHEREAS, she carries many different titles on behalf of Benton County, where we would otherwise need to create and fill additional positions to help maintain these job duties and responsibilities; and

WHEREAS, the mayor's current executive assistant holds a B.S. in Business Administration, has completed the Tennessee Basic Economic Development Course, has completed multiple courses offered by CTAS on budgets and accounting procedures for both counties and municipalities, and plans to enroll in the upcoming CCFO (Certified County Financial Officer) program in 2020; and

WHEREAS, according to the U.S. Department of Labor Bureau of Labor Statistics the average salary for the position of a County Mayor's Executive Assistant is listed as the following:
