PROCLAMATION FROM THE OFFICE OF THE COUNTY MAYOR TO HONOR AND RECOGNIZE SEPTEMBER 2020 AS SUICIDE PREVENTION AWARENESS MONTH IN BENTON COUNTY:

WHEREAS, suicide is one of the most disruptive and tragic events a family and a community can experience, with more than 1100 lives lost in Tennessee each year and an estimated 25 attempted suicides for each suicide death; and

WHEREAS, suicide is the 9th-leading cause of all deaths in Tennessee, the second-leading cause of death among youth ages of 10 to 24, and the first leading cause for children ages 10-17; and

WHEREAS, more than three lives a day are lost to suicide in Tennessee, which means we lose 22 Tennesseans each week and 97 people per month; and

WHEREAS, Tennessee veterans, active-duty military, and National Guardsmen face a disproportionate risk as compared to the general population, with more dying from suicide than combat; and

WHEREAS, public awareness of this tragic problem is the key to preventing further suffering and loss of life; and the risk for human self-destruction can be reduced through awareness, education and treatment as the highest risk for suicide is among the survivors of those who died by suicide or those who have attempted suicide; and

WHEREAS, suicide prevention has been declared a state priority by the Governor; and the Tennessee Legislature has declared teen suicide prevention as a state priority in partnership with the Tennessee Suicide Prevention Network to implement the Tennessee Strategy for Suicide Prevention; and

WHEREAS, Tennessee is a national leader in the effort to prevent suicide, being one of the first states to develop a suicide prevention and evaluation plan covering the lifespan; and

WHEREAS, the Governor of Tennessee has appointed a Suicide Prevention Network Advisory Council to coordinate the implementation of the Tennessee Strategy for Suicide Prevention; and

## COUNTY MAYOR'S NOTES FOR COMMISSION MEETING: AUGUST 17, 2020

#### **COURTHOUSE CLOSURE**

The increasing cases of COVID-19 is beginning impact our county greatly. I have saved my personal comments on this for the end of this summary. However, our staff who works in the county courthouse has directly been impacted, as of this date 4 have been confirmed with positive COVID-19 tests. As a result, we closed the courthouse for nearly 2 weeks (thru Aug 17<sup>th</sup>), minimized staffing when open, and incorporated a restrictive access and contact between our citizens and the staff to minimize possible exposure as well as promote a protective and healthy working environment. We have instituted "Mask Only" environments in all county buildings and offices as of Monday, August 10<sup>th</sup>.

#### **FAREWELL & WELCOME**

I want to take this opportunity to thank Commissioners Doug Vickers and Janet Higdon who will be leaving us at the end of this month for their services to Benton County over the last one and two years. Anyone who is willing to sacrifice time and effort it takes to attend meetings, study the issues, address your constituent concerns is to be commended. Thank you for your service and we wish you continued success and good health. We also want to welcome two new members to our county government – Mr. Dwayne Fowler and Mr. Michael Nunnery, both who are no strangers to our citizens. Both have been lifelong citizens of our county and active all of their life in county activities, issues and concerns. Mr. Fowler will replace Doug Vickers from the 4<sup>th</sup> District, and Mr. Nunnery will be replacing Janet Higdon from the 5<sup>th</sup> District. We look forward to seating you in our September commission meeting.

Also, a special mention to Property Assessor Ryan Hall on his reelection August 6<sup>th</sup>. He will serve another 4-year term. Lynn Cagle ran a commendable race and put forth a lot of hard work and tireless effort. We are lucky to have such great citizens in our county who desire to serve and we greatly appreciate both of these candidates for the love they have for Benton County.

### MAGIC VALLEY GOLF COURSE

I have proposed the extension of the MVGC Lease. I want to encourage commissioners to go out and visit the golf club and ask to ride around the property. The golf course is a tremendous asset to the quality of life in our county, as well as a tremendous tourism draw.

#### E-911

I have asked Property Assessor and E-911 Director to be available in case you have questions at our commission meeting, but we are in the process of appraising and valuing a tract of land the county owns or which E-911 has expressed interest in buying. There is a resolution asking the legislative body to support and allow me to conduct the sale of this property they have interest in. The actual approval came back in July 2019 when we conducted the large parcel sale, however due to the time that has passed and the recent efforts to get this project going, I wanted to re-visit this issue with the Commission.

We will ask E-911 to conduct their due-diligence, survey and provide the adequate legal services to map and record the parcel should they decide to buy the property. We believe our estimates of Fair Market Value will come in from \$45,000 to \$50,000. Much of the property is unusable, but

E-911 still will purchase the entire tract. I have asked that the sale proceeds roll over into the construction funding of our County Emergency Management Agency Office.

The bottom line is this property produces no tax impact to the county since we own it, there is no taxes received on it. We are able to support our valuable E-911 service, utilize a piece of property we have no plans to develop, and gain approximately \$50,000 in funds to invest back into Benton County public good and welfare. We are fortunate E-911 has proposed this win-win option.

## **GRANTS: PATSY CLINE MEMORIAL PARK**

As mentioned last month, we applied for a \$75,000 Tourism Enhancement Grant which if successful, will be applied at the Patsy Cline Memorial Park. I am happy to say we have been awarded that grant!

Ultimately, it will cost the county 5% of that cost (or \$3750) toward the grant writer fee with NWTN-DD, and an additional \$3750 as our out-of-pocket cash match. In essence, we will net out \$67,500 toward park infrastructure improvement. We have also budgeted an additional \$25,000 from our Governor's Grant to be applied toward upgrades in the park (lighting, gate, parking, and drainage).

With the grant funding we are looking to construct an earthen amphitheater and stage facility for entertainment events. We have been in contact with the Patsy Cline Museum administrative folks and are looking to make the grand opening one that will honor the families impacted by the tragedy as well as earn the respect of all in the country music profession.

The bottom line is we will put \$92,500 into needed improvements and enhancements of which \$0 / zero had to come from our Benton County tax base.

#### **GRANTS: TDOT MULTIMODAL**

Our Engineer has submitted applications for a 95/5 TDOT Multimodal Grant for a sidewalk project for the Holladay Community, from the inner core area near the school and thru to the Post Office and Holladay Baptist Church. This grant, valued at \$1,000,000 will cost the county \$50,000. We have allocated that funding from the Governor's Grant recently received so in essence, our match money is already budgeted and in the bank. We will do the same with an application for the City of Big Sandy's sidewalk project. Again, as with the above, the funds are already in the bank.

The bottom line is we will put \$2,000,000 into needed improvements and enhancements to these communities of which \$0 / zero had to come from our Benton County tax base.

### **GRANTS: AG**

We were not successful in being awarded an Ag Enterprise Fund grant, but the Ag Commissioner awarded us a discretionary grant of \$50,000. This is a 100% funded grant which will go towards the Ag Civic Center & Farmers Market.

## **COUNTY SPORTS COMPLEX**

The timbering is complete at the ballpark and we have the cash in hand for pursuing some parks and recreation grants to extend, enhance, and expand our park capacity as far as softball fields are concerned. With the obtainment of grant funding, we believe we can further leverage the development of a soccer field complex adjacent to the area where the sheriff's inmate garden is located. We hope to know more of our grant applications as they come open in the Fall timeframe. Our strategy is to leverage the \$150,000 from timber sales into additional parks & recreation grant funding that will amount upward to \$600,000 at little or no additional cost to the taxpayers other than the \$150,000 already in the bank. We will leverage land values of an unused industrial tract located where the Inmate Garden is toward the development of soccer fields which we believe can be accomplished without a cash investment. We will also use \$50,000 of the governor's grant money as the final step in paving and improving the roadway to and from the ballpark.

The bottom line is we will put up to \$600,000 into needed and capital improvements and enhancements of which \$0 / zero had to come from our Benton County tax base (other than sacrificing timber from the land).

## FARMERS MARKET COMPLEX

We are nearing the grant application phase toward directing financial awards toward the construction of our Ag Extension Civic Complex and Farmers Market. We will apply for a 50/50 matching Local Parks and Recreation Fund (LPRF) Grant through the State of Tennessee. Additionally, the City of Camden has agreed to allow us to apply for their LPRF Grant so long as we make the financial match. In leveraging Grant Funds already allocated in our budget as well as and our property purchase value toward the Farmers Market project, we will end up building this entire complex (estimated at \$1.1 to \$1.5 million dollars) for only the cost of the land (\$150,000). This project will also include the remodel of the strip-mall buildings, walking paths & sidewalks, fountains and splash-pad, adequate parking & paving, and a large Farmers Market Pavilion Building. Should the project with residual funds, those funds will be directed toward the completion of our Agricultural Extension and Civic Center construction.

Agriculture is the #1 Industry in Benton County! We have not done anything to recognize, assist, or award our farming community. It is time we move forward with this grand project which will put Benton County on the public forefront of Agriculture second to no other county in Tennessee. We have purposely chosen this site as it adjoins our County Fairgrounds, CO-OP, and in a primary historic business area of our county seat (Camden). What a tribute this will be to our farmers and county agricultural operations. Even University of Tennessee President Randy Boyd, on his visit to Benton County recently asked to be invited to the opening when we get to that point, and excitedly commented on how this complex will be a pride of University of Tennessee Agricultural Extension Offices.

The bottom line is we will put up to \$1,500,000 into this project which \$0 / zero had to come from our Benton County tax base. In essence we will have built this Farmers Market Complex for free!

#### BENTON COUNTY CREDIT STANDING

I have been in discussions with Moody's rating analyst about the financial standing for Benton County, and I am very pleased with their report (see below summary). Moody's (see <a href="https://www.moodys.com/">https://www.moodys.com/</a>) is one of the premier Investor and Credit rating agencies in the world, and they evaluate Benton County's financial status on a periodic basis. The last credit rating came from our General Obligation Bond refinance in 2017. Below is a draft summary of their official report to be released by the end of August:

Benton County, TN Annual Comment on Benton County Issuer Profile

Benton County is located in northwestern Tennessee. The county seat of Camden is approximately 70 miles west of Nashville. The county has a population of 16,112 and a population density of 41 people per square mile. The county's median family income is \$46,858 (4th quartile) and the June 2020 unemployment rate was 9.7% (2nd quartile). The largest industry sectors that drive the local economy are retail trade, manufacturing, and local government. We regard the coronavirus outbreak as a social risk under our environmental, social and governance framework, given the substantial implications for public health and safety and the economy. We do not see any material immediate credit risks for Benton County. However, the situation surrounding coronavirus is rapidly evolving and the longer-term impact will depend on both the severity and duration of the crisis. If our view of the credit quality of Benton County changes, we will update our opinion at that time.

#### **Credit Overview**

The credit position for Benton County is solid, though its A1 rating falls short of the median rating of Aa2 for US counties. The key credit factors include a very healthy financial position, a low debt burden, a moderate pension liability, an adequate tax base, but a low wealth and income profile.

**Finances:** The financial position of the county is robust and is a notable strength in relation to the assigned rating of A1. The cash balance as a percent of operating revenues (41.4%) is on par with the US median, and stayed the same between 2015 and 2019. Moreover, the fund balance as a percent of operating revenues (38.7%) is slightly stronger than the US median.

**Debt and Pensions:** Overall, the debt and pension liabilities of the county are low and are a modest credit strength in comparison to its A1 rating. The net direct debt to full value (0.7%) is consistent with the US median, and this metric fell slightly from 2015 to 2019. Furthermore, the Moody's-adjusted net pension liability to operating revenues (1.4x) is roughly equivalent to the US median.

Economy and Tax Base: Benton County has a sound economy and tax base, yet they are slightly unfavorable when compared to the A1 rating assigned. The full value per capita (\$63,528) is slightly below the US median. That said, this number increased significantly between 2015 and 2019. Additionally, the total full value (\$1 billion) is much smaller than other Moody's-rated counties nationwide. Lastly, the median family income is 63.4% of the US level.

#### **EMPLOYEE COMPLAINTS**

It has come to my attention that a county employee was told by their dept head and or elected official that they were NOT to speak to the mayor's office about anything related to their work environment, duties, or county issues. Any county employee is welcomed and has full right to bring matters to the county mayor. We administrate all employee benefits and, in most cases, human resource policies. Not all of these concerns or ideas relate to a peer, supervisor, official and such, but even if they did, I would hope they could bring their matters to the county mayor.

Additionally, I have an open-door policy and regardless of department, NO employee should be fearful for bringing concerns to the county mayor. This is a potential form of harassment or intimidation and a prime example of why we get lawsuits rather than preventing lawsuits. Additionally, there is a federal law protecting whistleblower type actions. I have 5 years' experience as an Army Inspector General and this is a prime example of why we have Inspector Generals. If I hear of an employee being harassed or threatened for bringing a legitimate concern to me, I will call in the state ethics board ASAP and file the complaint myself

#### COVID-19

I wanted to convey my thoughts and possible actions related to the increase of COVID-19 cases recently reported in Benton County.

As to the recent increase, this has been expected since March. We have commented in multiple briefings that the virus would continue to spread and that our county would be more impacted. We have consistently been in the lower tier of cases in Tennessee, ranging from as low as 5th to as high as 20th lowest of all 95 counties in Tennessee. Compared to other rural counties, we are fortunate to have stayed so low considering the major highways, interstate, and Tennessee River traffic running through our county, which brings potential exposure every day from more affected counties, cities, and states.

The question I have been asked the most relates to whether I have intentions to issue "Mask Mandates", which I usually reply that it is not my intention to issue a countywide mandate. However, I strongly encourage the wearing of mask in any setting that places oneself in close proximity to another person. Mandates by context have an implied enforcement element to them. A mandate for most practicable purposes would intended to be issued if there is a penalty as a result of not complying would it not? Our county law enforcement is not equipped to consider such measures of writing citations on individuals, and I do not believe this pandemic should place our government into such irrational and possibly unconstitutional actions.

However, as mentioned before, I strongly encourage the wearing of mask as an added protective element to one's health when in a public setting and strongly encourage businesses as well to take it upon themselves to put forth a safe operating environment rather than be mandated into such measure. I had hoped that as many businesses as possible would incorporate mask only operating environments, as they are the magnets of public gatherings where a risk is present. I have spoken to multiple businesses who have incorporated such measures that reside outside the city limit jurisdictions. Anything within the city limit jurisdictions of Big Sandy and Camden, I leave to their respective city mayors.

To respect the previously issued Tennessee Courts environment order, I have placed our courthouse in a "Mask Only" operating environment. I believe it is better to stay on the side of caution and why county operations will always do our best to promote a safe health environment.

Everyone has an opinion on a solution or behavior related to this viral threat. I believe we are learning something new every week, but the following remains true: this virus has profound negative impact on humans with underlying medical and physiological conditions, especially those above 50 years of age. Self-isolation, social distancing, mask, gloves, sanitizer, and good hygiene practices are effective against the possible exposure to the virus. Combine a series of or all of them and it only increases one's chances to deter being infected by the virus. We should be respectful of others health concerns as much as our own when outside the confines of one's home. Please do not ridicule those who wear mask or have a differing viewpoint on the virus.

We should be a unified community in wanting to eradicate this virus. This virus simply isn't going to be wished away or fade away on its own unless each individual takes some measure of healthy practices mentioned before. I encourage our citizens to simply take the virus and its impact on the community seriously. I encourage and trust you to do what is in the best overall interest of your, your loved ones, and your neighbor's health.

Pray for one another's health, pray for the families battling against this health threat, pray for patience and understanding, and pray for God to place His healing and protective hands upon Benton County.
